Please allow 6 weeks to be sure it arrives in time for the appropriate month.

At the next meeting you may find just the right person or just the right words said that will help you in hour grief work

Some of the number has moved away The distance is too great And they could not return today.


There are other chairs that remain unfulfilled. A mother, a father, or a son or daughter. Once viral to the family Now transcending spatial parting And feasting in glory.

## WHAT'D I MISS LAST MONTH?

Thoughts & Summary by Rick...

Marlen Maier and Noel Castiglia, two of our chapter's founders, looked back on their grief journeys over the last 20 years since their children died, and reflected on the "mileposts," provided insights into the issues and problems they have faced over the years, and discussed ideas on dealing with these issues and problems.

Marlen discussed the numbness, the devastation, and all of the searing emotions that she went through initially...and like so many of us have felt. She talked about the anger that was directed in many directions, anger at doctors, friends, and even her son, Eric, for being there no longer.

Noel, in describing his feelings after the loss of his daughter, Tria, had many similar feelings, and also dealt with a feeling of anger that took quite a while to overcome.

The point that Marlen articulated so well, later to be agreed to by Noel, was that one factor that helped them both to move along to a more bearable phase of their grief, was the opportunity to meet in a forum where others actually understood their pain. Of course, that forum was the Bereaved Parents. Knowing that what was discussed in the group stayed within the group, and that it was a place where you come to realize that all the feelings that you deal with was felt by others. This revelation helped them make a decision that prompted the formation of our chapter.

As Marlen shared, meeting with a support group with those who have gone through life's most cruel experience was much more therapeutic and healing than just being medicated and talked to by a doctor that did not have that same devastating experience. As she said, she began to feel again, like a whole person.

For all of us that have sat through "newly bereaved" sessions with both Marlen and Noel, we can attest to the comfort and understanding that they have given us. And I wonder how long it will take me to project and feel the inner peace that they both seem to have. You listen to them speak and then...you will see a tear in their eye, or a slight wavering in their voice as they talk about their beloved child. That's when you see that no matter now long it's been since our child has been gone, the loss of a child is something that will deeply affect us as long as our memories are with us. But with friends like Marlen, Noel, and all of those willing to share how they have dealt with their grief, our path to managing that grief will be a little easier to travel.

Thank you Marlen and Noel for sharing....

Note: This serves as a reminder of the value of the presentations that are given at our monthly meetings. The programs not only address how new attendees to our meetings may learn from the diversity of the presentation and presenters, but remind those that have been dealing with grief for a longer time that we still need all the help we can get. So we encourage your attendance at these meetings to take some thoughts home with you that just may help you.

#### What is a memory?

It is the faculty of beholding the golden rays of sunset after the night has fallen. It is the ability to bear in mind the sweet melody after the instruments have ceased playing. It is a conversation with someone who can no longer speak and seeing a smile on a face no longer there.
