Hope for the Thanksgiving Holiday

The holidays can be an especially difficult time of year for those who are grieving. When everyone around you seems happy and full of holiday cheer, you may want to just skip the holidays all together. The sights, sounds and smells of the holiday season can be overwhelming and the period of time leading up to the holidays can actually be worse than the day itself.

Before Thanksgiving Day, think about what might be tough and plan ahead, for example the “empty chair,” should you keep it in place or remove it from the table all together? Should the oldest child or another family member sit there now? Should you set a place in honor of your loved one? There’s no right or wrong answer, do what’s best for you and your family.

Be realistic....Don’t over schedule, you know yourself better than anyone. Set realistic goals and always have more than one plan. By having multiple plans – plan A, B and C – you can quickly move to the next plan if the previous one isn’t working or becomes too difficult.

It’s important to remember that you don’t have to do things the way you’ve always done them. It may be a good time to start some new traditions, this doesn’t mean you’re going to lose the old traditions; you can always go back to them or incorporate them again when you’re ready. Just because you’ve always put on a huge feast doesn’t mean you have to this year, have everyone bring a dish, have another family member host Thanksgiving dinner, or go out to a restaurant this year.

Address the “elephant in the room,” by acknowledging your loved one and including him or her in your gathering by lighting a candle, making a toast in his or her honor, or sharing favorite memories and funny stories about them. It may be difficult to start these conversations but it will benefit everyone around you and help each of you heal a little bit at a time.

A wonderful new tradition is to cover the table with a plain table cloth, provide permanent markers for family members and guests to write what they’re “thankful” for on the table cloth, a favorite memory or message to your loved one, and children can have fun by drawing pictures. Bring the tablecloth out at each holiday until it’s full and then start a new one!

Remember to give “thanks” for what you had and what you still have.....memories, love and feelings in our hearts can never be taken from us unless we let them. This year give thanks that the grief you feel is based on the enormous love you’ve shared!

Sharing groups, a key part of each Chapter meeting, will be held as desired for first-time attendees, and the newly and non-newly bereaved. **Meetings are held on the first Thursday of every month beginning at 7:30 p.m. and are open to anyone grieving the death of a child. Come around to the back of the church -- there is parking and an entrance directly into our meeting room. Doors open at 7:15 p.m.**

We are a self-help support organization dedicated to assisting parents, grandparents, aunts, uncles and siblings toward the positive resolution of grief following the death of a child. We provide information and education to extended family and friends. Our greatest strength as bereaved families is the unity we find in shared experiences which can lead us out of isolation, give us a place to "belong," and offer us hope that together – we can make it.

WHAT TO EXPECT AT OUR CHAPTER MEETINGS: Our Chapter gathers one evening a month to address topics and offer support to those who are mourning the death of a child. Our meetings last for approximately 2 hours. Sometimes we schedule a 30-minute presentation at the beginning of our meeting. When the speaker or panel has concluded the presentation, we introduce ourselves and say our child's name. We then take a short break before dividing into sharing groups. Sharing groups are facilitated by fellow Chapter members and are completely confidential. During this time, the issues that are discussed—particularly for the newly bereaved—focus on the issues facing participants today.

A Grandparent's Lament

My seven year old grandchild was killed in a tragic accident. We had such wonderful times together. He was the shining light of my life. And now he's gone. I feel sorry for my daughter and son-in-law, but they have lots of support from caring friends. No one seems to understand my agony. Grandparents mourn too!

How true, the grandparent-grandchild relationship is very special. With quality time, they provide the biggest laps, make few demands, and give many gifts. It has often been said that parents aren't supposed to bury their children. But, neither are grandparents supposed to bury their grandchildren. When a child dies, both parents and grandparents have lost a part of their future – one of the most horrific blows that human beings can endure.

There is the double assault of grieving for a grandchild while witnessing the suffering of your daughter and son-in-law. Your grief work may be different. Memories and attachments are not the same. Each of you has been rocked in individual paths to the very depths of your being in the attempt to patch together the pieces of your shattered lives. You must find a way to express what you are feeling or this suffering will stay inside you and fester. Seek out those with whom you can share your heartbreak. Pour out these emotions of grief and if necessary repeat them time and again. Perhaps keep a journal for your eyes alone to flood out your sorrow. But, most of all, talk. Talk to your friends, family, neighbors, clergy, support groups or a professional counselor. How sorely you need their expressions of help, warmth, and understanding.

The death of your grandchild may also result in an even closer relationship with your daughter, son-in-law, and the rest of the family. Recall the unforgettable memories of the past as you search for a meaningful future. Even in your overwhelming despair, you will realize that part of that child's life will live with you forever.

My Brave Young Men

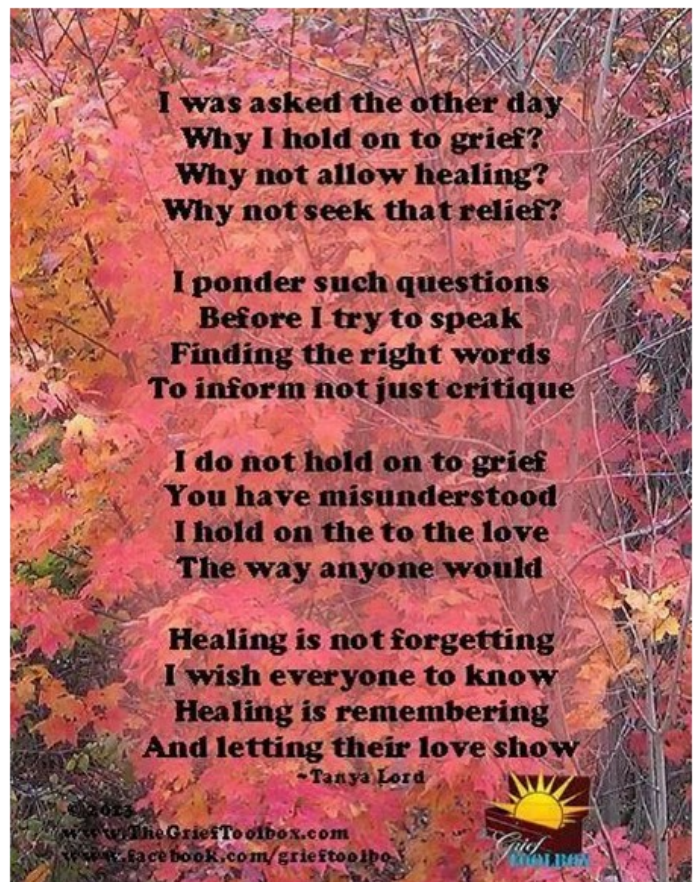
(Written by Glen Genseal, a Korean Veteran, on the Memorial to Korean Veterans, Springfield, Illinois Cemetery.)

Proof of Heaven: A Neurosurgeon's Journey into the Afterlife

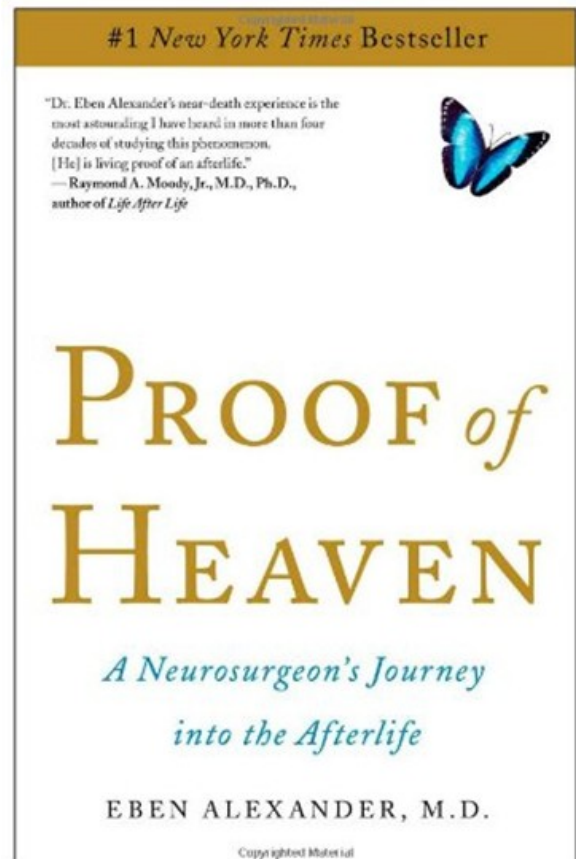

1) Child Loss Group

Monthly support group for parents experiencing the loss of a son or daughter of any age. Saturday: September 6, October 4, and November 1 from 10 a.m. to Noon. Saturday, December 6 from 9:30 a.m. to 12:30 p.m.

2) Suicide Grievors

Monthly Support Group with a professional facilitator for those 18 years and over who are grieving the death of a loved one by suicide - Tuesday: September 9, October 14, November 11, and December 9 – Evening. Please call 410-987-2129 for further information.

3) Support Group for those Grieving a Loss Due to Substance Abuse

This monthly drop-in/open support group is designed for those who have lost a loved one due to substance abuse and will address issues common to this particular type of loss. Monday: October 6, November 3, and December 1 from 6 p.m. to 7:30 p.m.

4) Perinatal Scrap-N-Share Group

This group is designed for individuals or couples coping with a difficult pregnancy diagnosis or infant loss. Participants can make a scrapbook, collage, or shadow box or just come for support with others who have experienced a similar loss. Group meets bi-monthly in the evening.

5) Career-Aged Widow and Widowers Support Group
