Dear Bereaved Parents:

The holiday season is, for many of us, one of the most difficult times in the journey of our grief. For us, it is even more so as we lost our beloved son Joey on December 17, 2012 just a few days short of Christmas day. Joey was the "planner", the "architect" of all our holidays, our trips, our family gatherings. And so, when we lost him, we felt as a boat adrift in the middle of the raging storm of our unspeakable sorrow. We have incessantly searched for a semblance of balance in this tsunami of despair, through interminable reading, counseling, support from our friends in our Bereaved Parents group and ceaseless, fervent prayer.



In that search we came upon a book entitled "A Decembered Grief". The author, Harold Ivan Smith, in response to our e-mail asking for permission to quote some parts of his book, closed with the following thought:

*" And remember, two things have to happen before Joey is really gone:  
You must stop saying his name and you must stop telling stories about him."*

Thus, we will continue to talk and share with all who want to hear the story of our beloved Joey. And in compass with that we vow to listen and get to know the names and stories of your children. While sharing the sacred part of what still lives in us, and the resolve to not allow their memories to fade, we can walk hand in hand down the path of this tragic journey we must follow until we embrace our children again.

And tell his stories:

At the funeral home I was downstairs in one of the reception rooms and this man introduced himself to me. "You've never met me before. My name is Brandon. I've known your son for about two and-a-half years and I owe everything I have to him."

He showed me a knitted monkey he was wearing in one of his fingers. Joey used to knit and sew stuff, he used it for de-stressing himself of the many, many responsibilities he had since he was about 25 years old. So the little puppet monkey Brandon was wearing was given to him by Joey. I have several and I will show it to you one day.

He told me he worked for this other company and every time he delivered beer to one of the restaurants Joey owned, Joey would ask him why didn't he go on his own? He said, Joey would tell him, "you create the recipes, you brew the beer, you look for the accounts and you deliver and then..."

you give this company 90% of all your work and the credit." He told me Joey said, "I will buy from you and promote you with the business' owners of H Street, believe me, you will succeed beyond what you can imagine right now."

To make the story short, less than two years after, Brandon owns one of the largest, most successful breweries in the DC area. The name is DCBrau. When Joey passed he brewed a beer in his honor and named it, "St. Joseph's Triple".

Sharing groups, a key part of each Chapter meeting, will be held as desired for first-time attendees, and the newly and non-newly bereaved. **Meetings are held on the first Thursday of every month beginning at 7:30 p.m. and are open to anyone grieving the death of a child. Come around to the back of the church -- there is parking and an entrance directly into our meeting room. Doors open at 7:15 p.m.**

We are a **self-help support organization** dedicated to assisting parents, grandparents, aunts, uncles and siblings toward the positive resolution of grief following the death of a child. We provide information and education to extended family and friends. Our greatest strength as bereaved families is the unity we find in shared experiences which can lead us out of isolation, give us a place to "belong," and offer us hope that together – we can make it.

**WHAT TO EXPECT AT OUR CHAPTER MEETINGS:** Our Chapter gathers one evening a month to address topics and offer support to those who are mourning the death of a child. Our meetings last for approximately 2 hours. Sometimes we schedule a 30-minute presentation at the beginning of our meeting. When the speaker or panel has concluded the presentation, we introduce ourselves and say our child's name. We then take a short break before dividing into sharing groups. Sharing groups are facilitated by fellow Chapter members and are completely confidential. During this time, the issues that are discussed—particularly for the newly bereaved—focus on the issues facing participants today.

## Holiday Pointers

---

A few things I have learned over the years.

1. **The apprehension is often worse than the holiday.** The days leading up to the holiday are also stressful, and sometimes more so than the holiday itself. Know this, and consider ways to alleviate the apprehension, because the holiday will come and you will be OK. Perhaps make time to spend in quiet reflection, just you and your child.
2. **Make a plan.** Having a plan will add some structure to follow for the day. Your plan can be simple. Like going away, lighting a candle for the day, doing nothing, reading, watching TV, going to a movie, spending time with family, etc. And your plan can always change, even at the last minute.
3. **Take care of yourself.** Grief affects you not only emotionally, but physically as well. So listen to your body and if you are tired, then rest. Try to eat healthy. Let others do more, like cooking, shopping, decorating, etc.
4. **Adjust your traditions and celebrations.** Life will never be the same for you, so expect to change the way you celebrate the holidays. Do not let others tell you what to do, in terms of socializing and celebrating. Start new traditions, no matter how small, such as light a special candle, start a memory box, buy an ornament, donate gifts in your child's memory. Do things that soothe your soul.



And remember that our children are with us always. We can no longer reach out with a hug or a kiss, for now they reside in our heart, soul and mind. In some ways, they are closer than ever.

### Our New Reality

Dedicated to those who've gone before, those who dwell here now and those yet to come.

We have been taught there are only 3 dimensions. More learned people believe there is a fourth and maybe even, a fifth. But I know there is another science has not yet defined.

When your child dies, "ceases to inhabit this Earth in bodily form", "lives on the other side of the rainbow", or however you want to say it, a whole entire other dimension or universe is immediately opened up to you. It is as if your reality has been slammed or hammered in the gut by an astronomically humongous bat and the result is an alternate, yet coexisting, terribly unwelcome, universe you must now and forever live in.

You can't enter it if your brother or sister dies; you can't enter it if your father or mother dies; you can't even enter it if your husband, wife or long-term partner dies. The only way to gain entrance is if your child dies. It doesn't matter whether your child is old or young, healthy or ill, all that matters is that they are taken from you.

This universe or dimension is filled with unimaginable and seemingly unrelenting pain. This dimension seems to have no bounds. The ostensibly ever-present emotional tribulation comes from every direction.

There often is no warning as to when it will strike. When you are fortunate enough to be graced by some reprieve you may find yourself blasted right back into this dimension of terror. You can take action to protect yourself, but no matter how hard you try there will be times when the dimension sneaks up on you, engulfs you, and takes you as its prisoner.

You may and will, at times, feel annihilated. You will, in all likelihood, at times feel hopeless. There will be times when this wretched dimension overtakes you to the point that you feel you should just give in and let it.

But take heart, dear wayfarer. There are others who have gone before you into this vast, torturous wasteland. We have walked where your shredded heart now treads. We will take your hand and guide you through those treacherous, razor blade mountains to more peaceful valleys where you might rest your weary head. We will guide you through that very narrow, and seemingly infinitely, blazing tunnel of despair to the other side where you will be able to glimpse hope and maybe even smile or laugh awhile.

Yes, oh forlorn one, there is hope to be had. This dimension - our dimension- is real, but we need not abide there all alone and lost. Our grief need not destroy us nor define us. Our children are our lives; our children are our heroes. Let us carry on together to let their memories live, in spite of this new reality. Let us turn this seemingly all-encompassing horror into one in which our children and our love for our children, shine through us. Let this new dimension be not only one of pain, but one of joy for the love that once was, that is, and that always will be.
