Like our Credo says, "We realize death does not discriminate against race, creed, color, income or social standing." That's also true of 24 of the 44 Presidents of the United States. We often forget how many people have suffered the same loss as each of us. It is especially interesting to realize that many of our American Presidents and their wives have lost one or more of their children. Since February 16th is President's Day, here is a listing of them. (Note: List below updated 1/25/09)

John Adams: Daughter, Susanna, age 2; Elizabeth, stillborn daughter; adult son, Charles, an alcoholic who died of cirrhosis at age 30. Charles died in 1800, shortly after the president lost his reelection bid.

Thomas Jefferson: Jane, one and a half years old; and a stillborn son; Lucy (I), 5 months old; Lucy (II), 2 years old; Mary, who died in 1804 as an adult from complications from childbirth. Thomas Jefferson carried a hair from one of his deceased children in a locket until the day he died.

James Monroe: Lost a son, age 2.

John Q. Adams: Lost an adult son, of suicide; and a one year old daughter.

Martin Van Buren: Lost an adult son.

William Harry Harrison: Lost 5 adult children, one child, age two (6 children total). President Harrison outlived his five grown children before himself dying a month after taking office, in the shortest presidency.

John Tyler: Had 15 children in all (!), and lost three, two adults and one infant.

Zachary Taylor: Lost three daughters: one 21, one 3, one 1.

Millard Fillmore: Lost his 22 year old daughter.

Franklin Pierce: Franklin and Jane Pierce lost all three of their children -- one infant, one four year old, and his eleven-year-old son who was hit by a train. Pierce's wife blamed his involvement in politics for the deaths, so he left public life to practice law. Later, he was encouraged to return to save the Democratic Party, and he went on to win the White House. Their eleven-year-old Benny, his only surviving child, was killed in a train accident in January 1853, two months before Pierce's inauguration.

Abraham Lincoln: Abraham and Mary lost three year old Edward, and eleven-year-old Willie (while in office). Abraham Lincoln once told his former law partner William Herndon that the death of his son Eddie prompted his return to public life. Lincoln lost his son William ("Willie") in 1862 in the middle of the Civil War. His death devastated first lady Mary Lincoln's psyche and furthered the president's empathy toward the nation's tremendous suffering.

Andrew Johnson: He lost two adult sons: one from a horse accident, and one from suicide.

Rutherford Hayes: Lost 3 sons under the age of two

James Garfield: Lost a 3 year old daughter, and a 2 year old son.

Chester Arthur: Lost a 2 year old son

Grover Cleveland: Lost a twelve-year old daughter Ruth, while in the White House.

President McKinley: He lost both of his children: three year old Kate and infant Ida. The only two children of William McKinley died before he took office. His wife, Ida, suffered from epilepsy and was prone to seizures, living much of her adult life as an invalid. Yet the affection McKinley showered on her was part of the charm that helped elect him. When McKinley was shot by an assassin, before he died he reportedly said, "Please don't tell Mrs. McKinley."

We are a self-help support organization dedicated to assisting parents, grandparents, aunts, uncles and siblings toward the positive resolution of grief following the death of a child. We provide information and education to extended family and friends. Our greatest strength as bereaved families is the unity we find in shared experiences which can lead us out of isolation, give us a place to "belong," and offer us hope that together – we can make it. WHAT TO EXPECT AT OUR CHAPTER MEETINGS: Our Chapter gathers one evening a month to address topics and offer support to those who are mourning the death of a child. Our meetings last for approximately 2 hours. Sometimes we schedule a 30-minute presentation at the beginning of our meeting. When the speaker or panel has concluded the presentation, we introduce ourselves and say our child's name. We then take a short break before dividing into sharing groups. Sharing groups are facilitated by fellow Chapter members and are completely confidential. During this time, the issues that are discussed—particularly for the newly bereaved—focus on the issues facing participants today.

Theodore Roosevelt: His twenty-year old son died during WWI.

Calvin Coolidge: His sixteen-year-old son died, while in the White House.

Franklin D. Roosevelt: Franklin and Eleanor lost an infant son

Dwight Eisenhower: He lost a three-year-old son

John F. Kennedy: He and Jacqueline had a stillborn daughter; and Patrick, died on August 7, 1963 when he was two days old while Kennedy was still in office, and four months before the assassination.

Ronald Reagan: He lost a daughter, one day old

George H. W. Bush: George and Barbara Bush lost their daughter when Robin died of leukemia at age 4, an event that also had a profound impact on her older brother, President George W. Bush.

Catching the Light: Coming Back to Life after the Death of a Child

by Genesse Bourdeau Gentry


This is a collection of poetry and musings depicting one mother's long journey back to a life of contentment, peace and connection after the death of her beloved child. The book is unique in that it describes a bereaved mother's gamut of emotions from the first years after her daughter died, to seventeen years after her death. The book covers the subjects of grief, guilt, the most difficult days, as well as the healing gifts that have helped her and how she has stayed connected with her daughter and other loved ones who have died.

After tragedy huge enough to break us, to shatter the pieces of beautiful glass that were our lives, we have a choice. Let the glass stay broken on the ground, covering the graves of our dead hopes and dreams forever, or pick up the fragments really look at them, put them together in a new way so we may heal and grow. And since it can never be put back exactly the way it was, the glass now has the potential to become a prism. Instead of light shining straight through

us, it is captured by all our facets, each finely polished by our deepening into grief. And as the fragments catch the light, more colors are revealed, and rainbows are formed, reflecting the pools of deep love and renewed hope we find inside.

A few months ago I realized that, by this point, I could be a grandma. And when the weight of my loss duplicated in souls never to meet, I sobbed. A pull-over-to-the-side-of-the-road-ugly cry sob. Grief for loss known – and unknown. For a title I don't get to have. For generations that never got to be.



In my line of work, I see expectant and new moms every day. Having lost a teenager, I never imagined this age bracket bothering me. What's not to love about babies? They've never been a trigger for me, only immediate joy. It wasn't until I met with a girl who is the age my son would now be, pregnant, that it hit me. **My baby would be old enough to have babies now...**

When we first lost Austin, there was a popular song on the radio called "Who You'd Be Today" by Kenny Chesney:

It ain't fair: you died too young, Like the story that had just begun, But death tore the pages all away....

Then, I grieved for what could've been. What didn't get to be. I imagined the faces of grandbabies, with my son's jet black hair and puppy dog eyes. Those babies I'd never get to hold.

But times passes and we forget, or rather maybe, push it away to heal and move forward. Six years later, life has a way of reminding us what we could've had.

Would you see the world? Would you chase your dreams? Settle down with a family. I wonder what would you name your babies?...

Then, it was only the midst of dream. When losing a 14 year old son, it is hard to imagine fully what the future may have held.

An' sometimes I wonder, Who'd you be today?

Now, time has fast forwarded and it is real, present tense, tangible. It is easier to grieve the loss of what might have been and didn't get to be. Surprisingly, a loss that not just I feel, but also our youngest, Austin's brother, feels as well.

I never mentioned the 'grandma moment' to my family. It was too raw, too emotional and difficult to share. Yet the other day, out of the blue, my now fourteen-year-old said, "I wish I could be an

uncle."

And my heart broke all over again.

He'll never get to be...Not in the truest sense. Not the uncle he would've been to his brother's babies. Another title our family won't experience. At least not yet.

Time passes and wounds heal but sometimes the passing of time opens new pains you never even expected to have."

How to Deal With Losing a Loved One: The Anniversary Date

The anniversary day of a loved one's death brings you face to face with reality. Their physical presence has gone and it becomes a very painful reminder of your loss. It marks the moment when life as you knew it changed forever and for many approaching that fateful date it can be a near crippling and overwhelming experience.

For so many, this "approaching" can range from months to weeks prior to the actual day itself. It slowly builds up to a crescendo. The calendar is the first reminder of what awaits you. As the date comes closer, dread starts weighing down your heart with the awakening of each new dawn. Next to join in is the horrendous thundering of thoughts racing wildly through your mind. The forerunners being "I'm dreading it" and "How am I going to cope?" Naturally your anxiety levels are increasing like a thermometer on a hot summer day and you just wish you could go to sleep and wake up when it's all over!

For so many of you it is an intensely painful experience. It was for me too but now the pain of my grief has shifted into something else. Yes there are still tears. Yes there is the missing and a longing to touch that which I cannot feel. But it is a day where now my sadness has become sacred.

If I had to describe a sacred anniversary day to you it would look like this:

- A day dedicated completely to your loved one and reserved wholeheartedly for them.

- A day devoted to remembrance and connection, founded on the unique bond and love you have and always will share.

- A day where you give yourself immunity from the pressures of the everyday world.

- A day belonging to comfort, gentleness and selfcompassion.

- A day where you recognize the power of you in having lived the previous year through your loss.

- A day that honors what your loved one has brought to your life. Who you are and who you are yet to be as a result of your love and your experience.

There are many ways you can plan this day in a way that feels right for you and in ways that honors the unique relationship you shared.


